



**READ CAREFULLY
WAIVER AND RELEASE OF LIABILITY

In consideration of Munster Airsoft furnishing services and/or equipment to enable me to participate in Combat Simulations and/or Airsoft games, I agree as follows:

I fully understand and acknowledge that;

- (a)** risks and dangers exist in my use of Airsoft equipment and my participation in Combat Simulation activities;
- (b)** my participation in such activities and/or use of such equipment may result in my injury or illness including but not limited to bodily injury, disease strains, fractures, partial and/or total paralysis, eye injury, blindness, heatstroke, heart attack, death or other ailments that could cause serious disability;
- (c)** these risks and dangers may be caused by the negligence of the owners, employees, officers or agents of MUNSTER AIRSOFT; the negligence of the participants, the negligence of others, accidents, breaches of contract, the forces of nature or other causes. These risks and dangers may arise from foreseeable or unforeseeable causes; and
- (d)** by my participation in these activities and/or use of equipment, I hereby assume all risks and dangers and all responsibility for any losses and/or damages, whether caused in whole or in part by the negligence or other conduct of the owners, agents, employees of MUNSTER AIRSOFT, or by any other person.

I, on behalf of myself, my personal representatives and my heirs, hereby voluntary agree to release, waive, discharge, hold harmless, defend and indemnify MUNSTER AIRSOFT and it's owners, agents, officers and employees from any and all claims, actions or losses for bodily injury, property damage, wrongful death, loss of services or otherwise which may arise out of my use of Airsoft equipment or my participation in Combat Simulation/Airsoft activities. I specifically understand that I am releasing, discharging and waiving any claims or actions that I may have presently or in the future for the negligent acts or other conduct by the owners, agents, officers or employees of MUNSTER AIRSOFT. I also confirm that any equipment I bring onto the site myself conforms to the MUNSTER AIRSOFT rules and regulations and to the law as laid down in the Criminal Justice Act 2006. I also acknowledge that I have read the Site Rules and Regulations and Safety Notices. We recommend full face masks(compulsory under 18 years), goggles will be worn at your own risk.

MEDICAL PERMISSION AUTHORIZATION

If the participant is of minority age (11) the undersigned gives permission for MUNSTER AIRSOFT to authorize emergency medical treatment as maybe deemed necessary for the person named below while participating in Combat Simulations and/or Airsoft games at MUNSTER AIRSOFT.
